- 3. Para III (x) of the guidelines provides that before sanctioning the SCA to TSP, it is pre-requisite to formulate specific schemes/ programmes that have a direct bearing on the economic development of Schedule Tribes as suitable to their social, economic and ecological situation. This provision has been further modified vide DO letter No. 14020/2/08-SG-I dated 30-01-2008. The proposals formulated by the State Government and submitted to this Ministry which conform to this requirement shall only be taken up for implementation.
- 4. No UC is due for rendition.
- 5. The State Government will implement the projects within the amount released by the Ministry during 2014-15 and keeping in view the spirit of the guidelines dated 04.03.2014 and other relevant instructions issued from time-to-time.
- 6. The State Government has to ensure that grant-in-aid is used for the purpose for which it is sanctioned after following due procedure in a transparent manner and after obtaining all necessary clearances as required under the various Central/ State Acts, Rules, regulations, etc. In case of construction of infrastructure facilities, norms and Schedule of Rates (SOR) fixed by the State Government should be followed.
- 7. The sanction is subject to final adjustment on the basis of audited figures of expenditure.
- 8. The expenditure to the tune Rs.4,03,00,000/- (Rupees Four Crore Three Lakh Only), is debitable to the :
