Terms and Conditions

Annexure-B

Subject: Auction for lifting of obsolete items like table, chairs, AC etc. from Ministry of Tribal Affairs.

- Agree to lift the items on "as is where is" basis.
- Agree to deposit Rs. 5000/- (Rupees five thousand only) as EMD (by DD or cash) before commencement of the auction.
- Deposit 25% of the bid value (including the EMD already deposited) in cash immediately on stroke of hammer.
- Deposit the balance 75% of the bid value in cash.
- Lift the items at the earliest. After submitting identity proof of self / residential address to ensure bona fides.
- The Ministry reserves the right to reject any bid including the highest and those lower than the reserve price.
- If the selected bidder does not show interest in lifting the goods, the EMD deposited by the bidder shall be forfeited and other actions initiated including resale of goods in question at the risk/cost of the defaulter; and
- From the time of depositing the total amount of lifting of the items, the disposed goods will be at successful bidder's risk in all respect like theft, fire, etc. and Ministry shall have no liability in this regard.
- Destruction of the material of the auctioned stores shall be as per the standing guidelines issued by Government.
