Subject: Release of Grant under 1st proviso to Article 275(1) of the Constitution during 2012-13 to the State Government of Tripura - sanction of 1st Installment (Capital Assets)

Sir,

I am directed to refer to the subject mentioned above and to convey the sanction of the President to the grants-in-aid (non-recurring) amounting to Rs. 317.72 lakhs under Article 275 (1) of the Constitution of India and to the release of Rs. 1,58,86,000/- (Rupees One Crore Fifty Eight lakh Eighty Six thousand only) to the State Government of Tripura, against the allocation of Rs.1250.00 lakh to the State for 2012-13, as payment of Central Assistance during 2012-13 towards Capital Assets for taking up the following activities as mentioned by the State Government in its letter No. F.15-53/TW/SP/2012-13(L)/7151-52 dated 11.06.2012.

2. No UCs is due for rendition upto 2010-11. The State has an unspent balance of Rs.927.10 lakh for the grant released during 2011-12.

3. You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of the Government of Tripura in accordance with procedure laid down in the Ministry of Finance's OM No. 2(45)/ 76-Spl Cell dated 30.8.1976 as modified by OM of even number dated 16.9.1976.

5. The entire assistance is subject to adjustment on the basis of the audited figures of expenditure for the State Annual Plan 2012-13.

6. The State Government will implement the projects within the amount released by the Ministry during 2012-13 and keeping in view spirit of the guideline laid down on Grants under Article 275(1) of the Constitution vide its letter No. 14011/9/2001-SG&C dated 2-7-2002 & D.O. letter No. 14020/2/2008-SG-1 dated 30.01.2008 and other instructions issued from time to time. A copy of the projects implemented by the State Government is required to be sent by the State Government to the Ministry. While taking up / implementing the projects submitted by the State Government vide their letter No. F.15-53/TW/SP/2012-13(L)/7151-52 dated 11.06.2012, the State Government would ensure that:-

- i. construction component of the project is based on the schedule of rates of CPWD / PWD or any other scheduled of rates approved by a competent authority.
- ii projects/s has the clearance of the State Government from the technical / financial / administrative angles.

7. The State Government is to transfer fund immediately within 30 days to the project implementing agencies and a copy of the fund transfer order may also be sent to this Ministry. It may be ensured that the grants are used for the purpose for which they are sanctioned after following the due procedure in a transparent manner and obtaining all necessary clearances as required under the various Central/State Acts, Rules and Regulations etc.

8. The progress reports of every quarter should be furnished indicating the physical and financial progress as per prescribed format already circulated. A Certificate of actual utilization of the grants received for the purpose for which it was received, may be furnished to the Ministry within 12 months of the closure of the financial year by the State Government.

9. This sanction issues in exercise of the delegated powers in consultation with Integrated Finance of the Ministry of Tribal Affairs vide their Diary No.166/JS&FA/2012 date 20.06.2012.
