The State Government will implement the projects within the amount released by the Ministry during 2013-14 and keeping in view spirit of guideline laid down on Grants under Article 275(1) of the Constitution, letter No. 14011/9/2001-SG&C dated 2-7-2002 & D.O. letter No. 14020/SG-1 dated 30.01.2008 and other instructions issued from time to time. The State Government is required to be transparent in the State Government to this Ministry.


7. The State Government is to transfer fund immediately within 30 days of the project implementing agencies and a copy of the fund transfer order also be sent to this Ministry. It may be ensured that the grants are used for the purpose for which they are sanctioned after following the due procedure in transparent manner and obtaining all necessary clearances as required under the various Central/State Acts, Rules and Regulations etc.

8. The progress reports of every quarter should be furnished indicating the physical and financial progress as per prescribed format already circulated. Certificate of actual utilization of the grants received for the purpose for which it was received, may be furnished to the Ministry within 12 months of the closure of the financial year by the State Government as per provisions of the GFR.
