**Subject: Payment of Non-recurring grant-in-aid to State Govt. of Kerala for construction of hostel for ST girls/ boys towards (i) 2<sup>nd</sup> and final instalment for completion of construction of 4 boys hostels sanctioned during 2013-14 and 1<sup>st</sup> Instalment for construction of 6 new Hostels (1 for boys & 5 for girls) under the scheme of Hostels for girls and boys.**

Sir,

I am directed to refer to State Government of Kerala's letter No.23187/PM/13/SCSTDD dated 17.12.2013, No.23246/E1/13/SCSTDD dated 31.10.2013 and No.26540/PM/13/SCSTDD dated 3.12.2013 and convey the sanction of the President of India to the non-recurring grant-in-aid Rs.32,61,89,080/- (Rupees Thirty Two Crore Sixty One Lakh Eighty Nine Thousand Eighty only) and to release grant-in-aid of Rs.19,49,62,540/- (Rupees Nineteen Crore Forty Nine Lakh Sixty Two Thousand Five Hundred Forty only) towards Rs.3,18,68,000/- (Rupees Three Crore Eighteen Lakh Sixty Eight Thousand only as 2<sup>nd</sup> and final instalment for completion of construction of 4 boys hostels sanctioned during 2013-14 and Rs.16,30,94,540/- (Rupees Sixteen Crore Thirty Lakh Ninety Four Thousand Five Hundred Forty only) as 1<sup>st</sup> Instalment for construction of 6 new Hostels (1 for boys & 5 for girls) and to release the same to the Govt. of Kerala for implementing proposal for construction of hostels under the Centrally Sponsored Scheme of Hostels for ST Girls and Boys. The GIA is for creation of Capital Assets. The details of grant-in-aid and location of hostels etc. is given at Annexure-1.

2. Certified that this sanction has been noted at S. No. 5 in Register of grants. At present no UCs are due and pending from the State Govt. in respect of this proposal.
3. The expenditure is debitable to Demand No. 97 -Ministry of Tribal Affairs, Major Head: 3601, "Grants-in-aid to State Governments"; 02- Grants for State Plan schemes (Sub Major Head), Minor Head: 796 Tribal Area Sub Plan, 08 -Umbrella Scheme for Education of ST Children 08.00.35-Grants for creation of capital assets (charged) for 2014-15.
4. Arrangements may be made to credit this amount to the State Govt. of Kerala in accordance with the procedure laid down in the Ministry of Finance O.M. No. 2(45)/76-Spl.Cell dated 30-8-1976 as modified vide O.M. of even number dated 16-9-1976 under intimation to this Ministry.
5. Funds allocated for the scheme shall not be diverted to any other programme without the prior approval of the Govt. of India.
6. Any unspent amount shall not be carried forward for expenditure and it should be surrendered to the Central Government as per instructions contained in the Department of Expenditure, Ministry of Finance O.M. No. G-26305/1/77-MFCGA dated 4<sup>th</sup> June 1977.
7. Boys' and Girls' hostels shall be constructed at the place identified. State Govt. shall not change the location without prior approval of the Ministry.

procedure and pattern of central assistance prescribed by the Planning Commission for Centrally Sponsored Schemes to this Ministry.

9. The State Govt. shall furnish physical progress report on the implementation of the Schemes to this Ministry every quarter.
10. Due to delay in taking up the construction activities, there may be cost overruns/escalations. Such overruns/escalations, if any, shall be met by the State Government from their own resources.
11. The land for the hostels will be provided by the State Govt. free of cost, on their own account. The cost of land will not be included in the estimated cost of construction of these hostels.
12. The relevant cost of construction may be as per the approved rates of CPWD/State PWD.
13. The Utilization Certificate shall be submitted within 12 months of the closure of the financial year 2014-15 and quarterly progress report in terms of physical and financial shall be submitted to this Ministry.
14. As per the norms of the Schemes these hostels should be completed within a stipulated frame of 2 years, as per the provisions of the revised scheme. Other norms of the revised scheme may strictly be followed.
15. This issues with the concurrence of Finance Division vide their Dy.No.3242/JS & FA dated 16.06.2014.
