The Expenditure involved will be met from within the Sanctioned Budget Grant of Ministry of Tribal Affairs under Demand No 97, under the Major Head-2225, Welfare of Scheduled Castes, Scheduled Tribes, Other Backward Classes and Minorities, 02-Welfare of Scheduled Tribes (Sub Major Head), 796 – Tribal Area Sub Plans (Minor Head), 09- Welfare of Scheduled Tribes -Other Expenditure, 07 Monitoring and Evaluation, 09.07.50 – Other Charges (Plan) for 2014-15.
