Sir,

I am directed to refer to the letter No.768-BCW/6S-39/2012 dated 26.02.2014 from the Government of West Bengal, Backward Classes Welfare Department on the subject mentioned above and to convey the sanction of the President of India to the payment of grant-in-aid of **Rs.14,43,510/- (Rupees Fourteen Lakh Forty Three Thousand Five Hundred Ten only)** as per details of Recurring expenditure enclosed as Annexure-I, after adjusting unspent balance of Rs.Nil for ongoing projects of Hostel for 50 STs to the organisation BHARAT SEVASHRAM SANGHA (Farakka Unit), AT/PO-Farakka, District Murshidabad, PIN-742212, West Bengal towards Full & Instalment for the year 2012-13 and 2013-14 on reimbursement basis during the year 2014-15. No Utilization Certificates are due for rendition and awaited at present.

2. The grant-in-aid shall be subject to the provisions of GFR, 2005. The list of documents to be maintained as per GFR is indicated in Annexure-II.

3. Since the grant has been sanctioned by way of reimbursement of expenditure already incurred on the basis of duly audited accounts, no UC is required in respect of sanctioned amount in terms of Note 1 of Rule No. 212(1) of GFR.

4. The accounts of all grantee Institutions/organisations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor-General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organisation is called upon to do so.
