Sub: Conservation-cum-Development (CCD) Plan for Particularly Vulnerable Tribal Groups (PTGs) (erstwhile Primitive Tribal Groups) of Manipur for 12th Five Year Plan under the Scheme of Development of PTGs- Grant-in-Aid (General) to the State Govt. of Manipur for 2014-15 thereof.

Sir,

I am directed to refer to Conservation-cum-Development for Particularly Vulnerable Tribal Groups (PVTGs) of Manipur for 12th Five Year Plan and to convey the sanction of the President for Rs.60,00,000/- and to the release of **Rs. 47,50,000/- (Rupees Forty Seven Lakh Fifty Thousand only) after adjusting an unspent amount of Rs.12,50,000/-** for Grant-in-aid (General) towards full & final instalment for the year 2014-15 for General Activities as per Annexure to the State Government of Manipur under the Central Sector Scheme of "Development of PVTGs" for the following activities/works proposed in the CCD Plan for 2014-15. No UCs are due for rendition.

- The grant-in-aid shall be subject to provisions of GFR, 2005.
- The funds shall be released by the State Government of Manipur for onward transmission to the implementing agencies **within one month** of issue of this sanction order.
- The works/activities shall be taken up in accordance with an **implementation schedule** submitted by Department of Tribal & Scheduled Caste Welfare of the State and submitted to the Ministry.
- The non-recurring grant is to be spent within 12 months from the date of sanction of this grant. The **Utilization Certificate (UC) for non-recurring and recurring grant for Rs.60.00 lakh shall be submitted by the State Govt. to the Ministry within 12 months from the date of sanction of this grant.**
- The State Government shall ensure that there is no unspent balance out of this grant left with them at the end of current financial year. The Unspent balance, if any, will be surrendered to the Ministry of Tribal Affairs.
- The financial assistance as provided under the scheme has been approved by Ministry of Finance. It shall be utilized for the purpose it has been sanctioned and **for the welfare of members of PTGs only.**
