3. The above mentioned amount is sanctioned under the scheme "Grant-in-aid to Tribal Research Institutes" during 2016-17.
4. The grant should be utilized for the purpose for which it has been sanctioned and should not be diverted for any other activities.
5. The assets created, facilities developed and activities undertaken through the grant released by this Ministry shall be voluntarily disclosed before the Gram Sabha concerned.
6. A representative of the Ministry shall be invited to participate in the Seminar/Workshop organized by the TRI/State Govt.
7. No UC is due for rendition. Utilization Certificate in respect of grant being released now should be submitted in forms GFR-19 A in terms of Rule 212 of GFR 2005.
8. The financial assistance sanctioned is provisional subject to final adjustment on the basis of audit figures of expenditure.

The expenditure is debitable to the **3601 Grants in aid to State Governments** (Major Head), 03- Grants for Central Plan Schemes (Sub Major Head), 796- Tribal Area Sub Plan (Minor Head)-02, Support to Tribal Research Institutes, 18.02.31-Grants in aid General (Charged) Under Demand No. 89 of the Ministry of Tribal Affairs for 2016-17 (Plan).
