In continuation of this Ministry's sanction letter of even no. 19.06.2015 on the above cited subject, I am directed to convey the sanction of the President of India for sanction of **Rs.126.50 Lakhs and to release an amount of Rs. 63.25 Lakhs (Rs. Sixty three lakhs twenty five thousand only) as 2nd & Final Instalment of grants-in-aid for the year 2015-16 to Rajasthan, Tribal Research Institute** under the Central Sector Scheme of "Support to TRIs" for the activities approved by the Ministry as per Annexure enclosed.

2. You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of the Government of Rajasthan in accordance with procedure laid down in the Ministry of Finance's O.M No. 2(45)/76-Spl Cell dated 30.8.1976 as modified by O.M of even number dated 16.9.1976.
3. A representative of the Ministry shall be invited to participate in the Seminar/Workshop organized by the TRI/State Government from time to time.
4. The grant should be utilized for the purpose for which it has been sanctioned and should not be diverted for any other purpose/activities.
5. As per Rule 236(1) of GFR-2017, the accounts of the Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and Internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so.
6. No Utilization Certificate (UC) has been rendered due and pending. The Utilization Certificate (UC) should be submitted as per Rule 239 of GFR in form 12-C in terms of GFR 2017.
7. The expenditure is debit to the Major Head 3601 - Grants-in-aid to state Government, 06 - Grants for Centrally Sponsored Scheme (Sub Major Head), 796 - Tribal area Sub Plan (Minor Head), 34 - Umbrell Programme for Development of Scheduled Tribes : Support to Tribal Institution, 02 - Support to Tribal Research Institutes, 34.02.31 - Grants-in-aid General (Charged) under Demand No. 96 of the Ministry of Tribal Affairs for the Year 2017-18.


8. The financial assistance sanctioned is provisional subject to final adjustment on the basis of audit figures of expenditure.
