Sir / Madam,

As you are aware Ministry of Tribal Affairs will be processing only such proposals from NGOs / VOs for assistance under subject scheme where applications have been submitted online. Instructions in this regard have already been issued by this Ministry vide letter of even number dated 22.08.2017 and 30.08.2017. It has been observed that a number of State Government Officers are yet to register on the portal. A number of applications from NGOs have been received in respect of many States. All authorised users of the State Governments / UT Administrations need to register on the portal ([www.ngograntsmota.gov.in/bo-login](http://www.ngograntsmota.gov.in/bo-login)) and apprise details of all the registered nodal Officers at District / State level for validation to ensure smooth migration of applications with concerned Officers and their timely processing. 
Sir/Madam,
