Subject: Monthly Summary of Principal Activities for August, 2020.

This is regarding important activities of Ministry of Tribal Affairs during the month of August, 2020.

2. As per the information received, "National Scheduled Tribes Finance and Development Corporation (NSTFDC)" disbursed loan of Rs. 26.66 Crores as on 31st August, 2020 for the year 2020-21, as against Rs. 10.91 Crores of the corresponding month of previous year. The total Annual target for the year, 2020-21 is Rs. 245.00 Crores.

3. A convergence plan was signed by Secretary (Tribal Affairs) and Secretary (M/o Rural Development) for convergence of Deendayal Antyodaya Yojana – National Rural Livelihood Mission (DAY-NRLM) and schemes of Ministry of Tribal Affairs.

4. Following steps have been taken by this Ministry to enhance education amongst ST students under the scheme Eklavya Model Residential School (EMRS):

4.1 Meetings were held with MeITY regarding establishment of IT infrastructure/ Smart Classroom in EMRSs and two Meetings were held for promotion of online learning in EMRSs.

4.2 One meeting of Revised Cost Committee was held with Ministry of Finance to discuss enhancement in construction cost of EMRS.

4.3 After several presentations by NIFT, the final design of Uniform, Logo and Motto for all EMRSs have been finalized during the month.

4.4 MoU has been signed between NESTS and STEP app (EDUISFUN Technologies Pvt. Ltd.) during this month.

5. As per information received from State Governments, till 31.03.2020; 42,51,545 claims (41,02,437 individual and 1,49,108 community) have been filed and 19,83,504 titles (19,07,126 individual and 76,378 community) have been distributed. A total of 37,36,057 (87.88%) claims have been disposed of under the ST and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006.

6. Incumbency details of all posts in the Ministry and its organizations falling under ACC purview have been updated on AVMS.

7. During the month of August, 2020, 114 e-files have been created by this Ministry in e-office.
