

Subject: Monthly Summary of Principal Activities for February, 2021.

This is regarding important activities of Ministry of Tribal Affairs during the month of February, 2021.

EMRS Activities:

- 2.1 One Review Meeting was held by Advisor to Hon'ble PM to review the progress of EMRSs.
- 2.2 One Press Conference was held by Secretary(Tribal Affairs) on Budget Announcement of the scheme of EMRS.
- 2.3 One Review Meeting with the State of Meghalaya was held to discuss issues of various schemes including EMRS & Grants.

NSTFDC Activities:

3.1 National Scheduled Tribes Finance and Development Corporation (NSTFDC) provides concessional financial assistance to eligible Scheduled Tribes for undertaking Self-Empowerment Ventures. NSTFDC channelizes its funds through Government owned State Channelizing Agencies (SCAs), nominated by the respective State/ UT Governments, National Cooperative Development Corporation, certain PSU Banks, Regional Rural Banks and others.

3.2 As per the information received, 'National Scheduled Tribes Finance and Development Corporation (NSTFDC)' during the month of February, 2021 sanctioned projects worth of Rs.28.02 crores and disbursed loan of Rs.129.66 crores. The total Annual target for the year, 2020-21 is Rs.245.00 crores.

3.3 CMD, NSTFDC visited Guwahati where field inspections of 25 hand-loom trainees of Rani, Assam were undertaken.

3.4. Executive Director, National Dairy Development Board (NDDB) visited NSTFDC HO and held discussion regarding possibility of tie-up between NDDB and NSTFDC for extending concessional financial assistance to the target group. Further, deliberations were also made for undertaking skill development training through NDDB.

4. Standing Committee on Social Justice & Empowerment under the Chairmanship of Smt. Rama Devi, Hon'ble Chairperson, took evidence of the Secretary(TA) on 24.02.2021 on examination of Detailed Demand for Grants of the Ministry of Tribal Affairs for the year 2021-22.

5. As per information received from State Governments, till 31.12.2020, 42,59,385 claims (41,09,105 individual and 1,50,280 community claims) have been filed and 19,97,778 titles (19,20,507 individual and 77,271 community claims) have been distributed. A total of 37,51,677 (88.08%) claims have been disposed of under the ST and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006.

6. During the month of February, 2021, MOU has been signed between Ministry of Tribal Affairs and TRIFED under the Institutional Support Scheme for the year 2020-21.

7. Incumbency details of all posts in the Ministry and its organizations falling under ACC purview have been updated on AVMS portal.

8. During the month of January, 2021, 164 e-files have been created by this Ministry in e-office.
