Subject: Monthly Summary of Principal Activities for July, 2019.

This is regarding important activities of Ministry of Tribal Affairs during the month of July, 2019.

2. As per the information received, "National Scheduled Tribes Finance and Development Corporation (NSTFDC)" disbursed loan of Rs.2.44 crores as on 31st July, 2019 for the year 2019-20. The total Annual target for the year, 2019-20 is Rs.228.00 crores.

3. The National Scheduled Tribes Finance and Development Corporation (NSTFDC) organized an Awareness camp at Dimapur in Nagaland on 06/07/2019 to disseminate information about NSTFDC schemes. Further Tribal Entrepreneur meet was held wherein 60 Tribal Entrepreneurs attended the programme.

4. Government has also decided to extend coverage of the Scheme "Special Central Assistance to Tribal Sub-Scheme (SCA to TSS)" to pan North Eastern States thereby including four States of Arunachal Pradesh, Mizoram, Meghalaya and Nagaland, which were hitherto left out from the benefit of the Scheme.

5. Incumbency details of all posts in the Ministry and its organizations falling under ACC purview have been updated on AVMS. There has been no case in which ACC directions have not been complied with.

6. A meeting was held with 24 States on 22/07/2019 to discuss the pending issues and to review physical and financial progress of projects sanctioned under the scheme of Article 275(1) of the Constitution, SCA to TSS and development of PVTG.

7. During the month of July 2019, 81 E-files have been created by this Ministry in e-office.
