**Subject: Monthly Summary of Principal Activities for June, 2021.**

This is regarding important activities of Ministry of Tribal Affairs during the month of **June, 2021**.

2. With regard to functioning of Eklavya Model Residential Schools (EMRS), a review meeting with all State Governments/UT Administrations was held during the month to monitor the progress of construction of new schools, status of CBSE affiliation and finalization of Recruitment Rules for Teachers.

2.1 The Parliamentary Standing Committee on Social Justice and Empowerment took the evidence of the Representatives of this Ministry on the functioning of Eklavya Model Residential Schools (EMRS) on **30<sup>th</sup> June, 2021**.

2.2 A Sickle Cell Conclave was held on **19<sup>th</sup> June, 2021** in the presence of Hon'ble Minister of Tribal Affairs and Hon'ble Minister of State for Tribal Affairs which was attended by various stakeholders. The conclave was held to address sickle cell in a mission mode. Various issues related to redressal of SCD such as data on prevalence of the disease, uniform screening at PHC/CHC and use of new technologies in screening programme were taken up during the conclave. One of the highlights of the event was flagging off of Unmukt MMU at Khunti, Jharkhand and Kanker, Chhattisgarh

3. During the month of June 2021, Tribal Health Cell started operation, subsequent to joining by Team Leader Ms. Vinita Srivastava.

4. During the month, under India@75 – **Bharat Ka Azadi Ka Amrut Mahotsav**, Ministry along with National Tribal Research Institute, NTRI (IIPA), New Delhi conducted a three days "**Capacity Building Program for Master Trainer of the ST PRIs**", which was organized in collaboration with TRI – MP from **16<sup>th</sup> to 18<sup>th</sup> June, 2021**. This program was virtual through WebEx and around 50 District level Master trainers of Madhya Pradesh were trained.

5. National Scheduled Tribes Finance and Development Corporation (NSTFDC) provides concessional financial assistance to eligible Scheduled Tribes for undertaking Self-Empowerment Venture. NSTFDC channelizes its funds through Government owned State Channelizing Agencies (SCAs), nominated by the respective State/ UT Governments, National Cooperative Development Corporation, certain PSU Banks, Regional Rural Banks and others. In this regard, the status of targets and achievements for the year 2021-22 is as under:

5.1 NSTFDC has sent letters to all banks implementing Prime Minister Employment Generation Programme (PMEGP) scheme informing them about NSTFDC schemes available for PMEGP refinance. They have been requested to avail refinance under NSTFDC scheme by signing MoU with NSTFDC. NSTFDC has also been put on board of PMEGP portal. The login facility will enable NSTFDC to view applications received from tribals for PMEGP scheme through banks.

5.2 In order to formulate a new scheme "Support for Marginalized Individuals for Livelihood and Enterprise (Tribals)" the channelizing agencies have been approached to share information about COVID related casualties of NSTFDC target group.

6. Under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 as per information received from State Governments, till 28.02.2021; **42,64,820 claims** (41,14,501 individual and 1,50,319 community claims) have been filed and **20,01,919 titles** (19,24,417 individual and 77,502 community claims) have been distributed. A total of **38,03,185 (89.18%)** claims have been disposed of.

7. Incumbency details of all posts in the Ministry and its organizations falling under ACC purview have been updated on AVMS.

8. The Ministry of Tribal Affairs has been successfully onboarded on SANDES platform (an instant messaging platform developed by Government of India).

9. In line with making E-Governance as an essential part of Digital India, during the month of June, 2021, 139 e-files have been created by this Ministry in e-office.
