Subject: Monthly Summary of Principal Activities for October, 2020.

This is regarding important activities of Ministry of Tribal Affairs during the month of October, 2020.

2. As per the information received, "National Scheduled Tribes Finance and Development Corporation (NSTFDC)" disbursed loan of Rs. 33.27 Crores as on 31st October, 2020 for the year 2020-21. The total Annual target for the year, 2020-21 is Rs. 245.00 Crores.

3. As per information received from State Governments, till 30.06.2020; 42,52,154 claims (41,03,001 individual and 1,49,123 community claim) have been filed and 19,85,632 titles (19,09,249 individual and 76,383 community claims) have been distributed. A total of 37,40,997 (87.98%) claims have been disposed of under the ST and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006.

EMRS Activities:

4.1 SOP/Guidelines for re-opening of EMRSs after COVID-19 Lock down were shared with the State Governments.

4.2 The Bid for procurement of tabs for EMRS students has been successfully submitted on GeM portal during the month.

4.3 Meeting of Revised Cost Estimate Committee was held to discuss enhancement in construction cost of EMRS.

Project Appraisal Committee Meetings :

5.1 Project Appraisal Committee meetings with 4 States through VC were held during the month for appraisal/ approval of project proposals under the scheme 'Grants under Article 275(1) of the Constitution'.

5.2 Project Appraisal Committee meeting was held with 3 States & UT of Andaman & Nicobar Islands during the month for appraisal/ approval of project proposals for 2020-21 under the scheme Development of Particularly Vulnerable Tribal Groups (PVTG)s.

6. The Meeting of Members of SGoS on Welfare was held on 6th October, 2020 for discussions on the Agenda items, circulated by Cabinet Secretariat and prior to the same, the meeting of AS/JS level officers was held on 5th October, 2020. The presentation of SGoS – Welfare to Cabinet Secretary was held on 09 October, 2020.

7. Officers of this Ministry along with Hon'ble Minister, Tribal Affairs and Hon'ble Minister of State have taken pledge to fight against Covid-19 on 9th October, 2020 during the month.
8. The officers and Staff of this Ministry have taken Rashtriya Ekta Diwas Pledge on 31st October, 2020 on the occasion of Observance of Rashtriya Ekta Diwas.
9. Vigilance Awareness Week was observed in the Ministry from 27.10.2020 to 02.11.2020 with "Zero Tolerance against Corruption". Also, Officers of this Ministry have taken Integrity pledge on 27th October, 2020 during the month.
10. A Meeting was held on 28th October, 2020 between Secretary, Ministry of Tribal Affairs (MoTA) and Secretary, Ministry of Panchayati Raj (MoPR) regarding issues of mutual concern as well as for collaboration between the two Ministries.
11. Incumbency details of all posts in the Ministry and its organizations falling under ACC purview have been updated on AVMS.
12. During the month of October, 2020, 105 e-files have been created by this Ministry in e-office.
13. Andhra Pradesh Stree Nidhi has been appointed as Channelising agency of NSTFDC for extending loans in State of Andhra Pradesh.
