Subject: **Monthly Summary of Principal Activities for June, 2020.**

This is regarding important activities of Ministry of Tribal Affairs during the month of June, 2020.

2. Hon'ble Minister of Tribal Affairs presided over a webinar hosted by Dalit Indian Chamber of Commerce and Industry (DICCI) on **“Relief Measures for Scheduled Tribes Entrepreneurs to Revive Business Post COVID-19 Lock Down”**.

3. A detailed review meeting (virtual) with 26 States was held on 12.06.2020 under the scheme of Grants under Article 275(1) and Eklavya Model Residential School.

4. For the first time, a Separate Category of Awards for EMRS has been created as **‘National Awards for Teachers’**.

5. As per the information received, "National Scheduled Tribes Finance and Development Corporation (NSTFDC)" disbursed loan of Rs. 14.51 Crores as on 30th June, 2020 for the year 2020-21.

6. As per information received from State Governments till 31.01.2020, 42,50,602 (individual + community) claims have been filed and 19,82,103 (individual + community) titles have been distributed under the ST and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, (FRA, 2006 in short). Further, 37,39,286 (87.97%) claims have been disposed of under the Act.

7. A meeting of AS/JS Level Officers of SGoS on Welfare was held on 30.06.2020 through VC for discussion on issues relating to the Action Points of Transformative initiatives on the eSamiksha portal.

8. Incumbency details of all posts in the Ministry and its organizations falling under ACC purview have been updated on AVMS.

9. During the month of June, 2020, 103 E-files have been created by this Ministry in e-office.
