

**Subject: Monthly Summary of Principal activities for November, 2018.**

1. As per information received from State Governments till 30.11.2018, 42,19,741 claims (40,73,503 individual and 1,46,238 community claims) have been filed and 18,89,835 titles (18,18,121 individual and 71,714 community claims) have been distributed. A total of 38,24,180 (90.63%) claims have been disposed of.
2. As per the information received "National Scheduled Tribes Finance and Development Corporation (NSTFDC)" disbursed loan of Rs.35.24 crores as on 30th November, 2018 for the year 2018-19. The total Annual target for the year, 2018-19 is Rs.220.00 crores.
3. During the month of November,2018,this Ministry through its Tribal Cooperative Marketing Development Federation, (TRIFED) organised Adi-Mahotsav,the National Tribal Festival at Delhi Haat, INA, Delhi from 16th to 30th November,2018 wherein the tribals from the States showcased their tribal arts,crafts,culture and cuisine besides marketing their products. This Festival attracted large number of visitors, both domestic and foreign to enjoy the traditional tribal arts and crafts. On the concluding day, Ms. Mary Kom, credited with 6th title of International Women Boxing Championship and also the Brand Ambassador for TRIFED for marketing was felicitated at the venue of the festival by this Ministry. Hon'ble Minister of Tribal Affairs and Minister of State for Tribal Affairs were present on the occasion.
4. This Ministry has organized an interaction session with 26 States through Video Conference wherein Secretary (Tribal Affairs) took stock of the progress of the ongoing schemes being implemented by the Ministry in the concerned States.
5. Incumbency details of all posts in the Ministry and its organizations falling under ACC purview have been updated on AVMS. There has been no case in which ACC directions have not been complied with.
6. During the month of November 2018, 79 E-files have been created by this Ministry in e-office.
