Subject: Monthly Summary for the Cabinet – September, 2018.

1. As per information received from State Governments till 30.09.2018, 42,01,801 claims (40,56,465 individual and 1,45,336 community claims) have been filed and 18,72,190 titles (18,01,938 individual and 70,252 community claims) have been distributed. A total of 38,09,382 (90.66%) claims have been disposed of.
2. National Scheduled Tribes Finance and Development Corporation (NSTFDC) has disbursed loan of Rs.15.38 crores till the month of September, 2018. The total Annual target for the year 2018-19 is Rs. 220.00 crores.
3. During the month of September, 2018, officers of this Ministry have visited several States and UTs including NE States and participated in the observation of Poshan Maah (National Nutritional Month) at the State Level.
4. This Ministry has observed Swachhta Hi Seva Pakhwara from 16th September to 2nd October, 2018 wherein advisories were issued to all the EMRSs and Ashram Schools etc. to maintain cleanliness all around and sensitize the local people on this aspect.
5. Incumbency details of all posts in the Ministry and its organizations falling under ACC purview have been updated on AVMS. There has been no case in which ACC directions have not been complied with.
6. Hindi Pakhwara was observed from 1st to 15th September, 2018 .
7. During the month of September 2018, 98 E-files have been created by this Ministry in e-office.
