It has been decided that the portal will be open from **1st March, 2018 to 31st March, 2018 for NGOs / VOs** to apply **proposals for the year 2018-19** and **State Governments / UT Administrations** need to submit duly recommended proposals for the year 2018-19 to this Ministry **by 15th April, 2018**.
