**Subject: Meeting of Project Appraisal Committee (PAC) for appraisal and approval of Annual Plan 2018-19 of the State Governments in respect of Special Central Assistance to Tribal Sub-Scheme (SCA to TSS), Grants under proviso to Article 275(1) of the Constitution and Development of Particularly Vulnerable Tribal Groups (PVTGs) – regarding.**

Sir / Madam,

Please refer to this Ministry's letter of even No. dated 13.04.2018 on the above cited subject. As you are aware, annual plan of the State Governments for the year 2018-19 under the above scheme has to be approved by the Project Appraisal Committee (PAC) in this Ministry.

2. It is now decided to hold the PAC meetings to appraise and approve the annual plan for 2018-19 between 22.5.2018 to 24.5.2018 as per schedule at **Annexure**. In view of above, it is requested to furnish a composite proposal to this Ministry for 2018-19 at an early date along with a power-point presentation, after approval by the designated Committee in the State Government. Tentative allocation for the States under the above schemes may be kept at the same level as the last year. The State Government may submit a proposal around 1.25-1.50 times of their allocation. The following documents should be sent immediately to this Ministry for the above schemes:

- (i) For activities of creation of capital assets, progress report along with geo-tagged photograph for the approved activities during last five years (activities-wise).
- (ii) For beneficiaries-oriented activities, progress report along with details of beneficiaries including aadhar number, for the approved activities during last five years (activities-wise).
- (iii) Utilization Certificate as per the format of GFR, 2017.



- (iv) Details of students enrolled in each of the EMRSs during the academic year 2018-19 along with location/address of EMRSs. Construction status of new EMRS which are not yet functional may be mentioned.
- (v) Sector-wise physical and financial achievement/allocation of TSP funds alongwith outcome of programmes implemented for tribal development in the State during 2013-14 to 2017-18.
- (vi) For Development of PVTG scheme, PVTG population figure in the State based on baseline survey should be intimated to this Ministry. Establishment of micro plan projects should be included in the plan.

3. The annual plan should be need based for the overall development of the tribal population. Districts having more that 50% ST population and aspirational districts may be focused while formulating the plan.

4. PAC meetings have to be attended by Principal Secretary / Secretary, Commissioner (in charge of) Tribal Development.
