Sir,

I am directed to convey the sanction of the President of India to release an amount of Rs. 24.38 Crore ( Rupees Twenty Four Crore Thirty Eight Lakhs) grants-in-aid for the year 2017-18 to Gujarat for setting up of Museum/memorial for Tribal Freedom Fighter in Garudeshwar, Govt. of Gujarat, under the Central Sector Scheme of "Support to TRIs" for the activities approved by the Ministry.

2. You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of the Government of Gujarat in accordance with procedure laid down in the Ministry of Finance's O.M No. 2(45)/76-Spl Cell dated 30.8.1976 as modified by O.M of even number dated 16.9.1976.
3. The grant should be utilized for the purpose for which it has been sanctioned and should not be diverted for any other purpose/activities.
4. As per Rule 236(1) of GFR-2017, the accounts of the Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and Internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so.
5. Utilization Certificate (UC) has been rendered due and pending. The Utilization Certificate (UC) should be submitted as per Rule 239 of GFR in form 12-C in terms of GFR 2017.
6. The expenditure is debitable to the Major Head 3601 - Grants-in-aid to state Government, 06 – Grants for Centrally Sponsored Scheme (Sub Major Head), 796 – Tribal area Sub Plan (Minor Head), 34 – Umbrella Programme for Development of
