

5. You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of the Government of Madhya Pradesh in accordance with procedure laid down in the Ministry of Finance's OM No. 2(45)/76-Spl Cell dated 30.8.1976 as modified by OM of even number dated 16.9.1976.

6. Diversion of funds and deviation from the norms of the scheme shall not be allowed. The conditions of eligibility, including inter-alia the condition of maximum prescribed income ceiling of parents must be followed.

8. The State Government may please acknowledge the receipt of this letter and report the expenditure incurred every Quarter.
