3. The works/activities shall be taken up in accordance with an implementation schedule drawn by Tribal Development Department of the UT Administration and submitted to the Ministry.

4. The Utilization Certificate for non-recurring and recurring grant will be submitted by the State Govt. to the Ministry as per Rule 239 of the GFR 2017 in Form GFR-12-C.

6. The financial assistance as provided under the scheme has been approved by Ministry of Finance. It shall be utilized for the purpose it has been sanctioned and for the welfare of members of PVTGs only.
7. The financial assistance given to ITDPs/ITDAs and TRIs should be deemed to have been given to the UT Administration concerned and rules and regulation governing the grants-in-aid to States/UTs shall apply to them.
8. Physical and financial Progress in respect of activities to be undertaken in this regard shall be reported every quarter.
9. The Drawing and Disbursing Officer of this Ministry is authorized to prepare bill for an amount of Rs, 1,00,00,000/- (Rupees One Crore Only) and Pay & Accounts Office is authorized to please the payment to Andaman Adim Janjati Vikas Samiti, Secretariat Complex, Port Blair, Andaman & Nicobar islands an autonomous society of UT Administration of A&N Islands through electronic transfer directly in their saving/current account no.33370884924 in State Bank of India branch at Port Blair and IFSC Code No.SBIN0000156.
10. The implementing agency shall allow the representative of this Ministry or the independent agency appointed by this Ministry or the UT Administration to inspect actual working of the scheme.
